Consumer advisor and special counsel to Governor Reubin O'D. Askew, Arthur J. England, Jr. will address today's graduating class.

Mr. England is a member of both the Florida and New York Bars and is also admitted to practice before the United States Tax Court and the Supreme Court of the United States.

After obtaining his undergraduate degree in Economics from the University of Pennsylvania's Wharton School of Finance and Commerce, Mr. England received his Bachelor of Law degree from that university's School of Law in 1961. While there, he was elected to the Order of the Coif and served as Research Editor of the Law Review. In 1972, the University of Miami School of Law awarded Mr. England his Masters of Law degree in Taxation.

Nationally recognized as a prominent expert on corporate income taxation, Mr. England has served as special Tax Counsel to the Florida House of Representatives. He has been a partner in the firms of McCarthy, Steel, Hector and Davis in Miami and Culverhouse, Tomlinson and Decarion also in Miami. He was an associate with Dewey, Ballantine, Bushby, Palmer and Wood of New York.

His active career has included teaching Commercial Law for the American Banker's Association and being appointed an Adjunct Professor of Law at Florida State University. In addition, Mr. England has authored numerous publications and lectured throughout the state in recent years.

Oath of Admission to the Florida Bar

I DO SOLEMNLY SWEAR:

I will support the Constitution of the United States and the Constitution of the State of Florida.

I will maintain the respect due to Courts of Justice and judicial officers;

I will not counsel or maintain any suit or proceeding which shall appear to me to be unjust, not any defense except such as I believe to be honestly debatable under the law of the land;

I will employ for the purpose of maintaining the causes confided to me such means only as are consistent with truth and honor, and will never seek to mislead the Judge or jury by any artifice or false statement of fact or law;

I will maintain the confidence and preserve inviolate the secrets of my client, and will accept no compensation in connection with his business except from him or with his knowledge and approval;

I will abstain from all offensive personalities and advance no fact prejudicial to the honor or reputation of a party or witness, unless required by the justice of the cause with which I am charged;

I will never reject, from any consideration personal to myself, the cause of the defenseless or oppressed, or delay any man's cause for lucre or malice. So Help Me God.
