OUTSTANDING ALUMNUS AWARD-In recognition and appreciation of devotion and service to the College of Law, the legal profession, and the State of Florida.

PHI KAPPA PHI is a national honor society whose primary objective is the recognition and encouragement of superior scholarship in all fields of study. Honor graduates within the top ten per cent of each class are eligible for election.

UNIVERSITY OF FLORIDA LAW REVIEW-Appreciation for the members of the Editorial Board elected on the basis of scholarship and past performance in law review work, who have given of their time and service in publishing the Law Review, receiving intensive training in legal research, organization, analysis, and style.
